**RE:** Revised Second Collections and Annual Catholic Appeal

Attached are the dates for the mandated and optional second collections to be taken up in every parish in the Archdiocese of Portland in 2019. **Please remember that the mandated collections are just that – they must be taken up in each parish and mission and should be done on the dates specified.**

I am sending out this second memo and collection list as we needed to add the Triennial National Collection for the Archdiocese for Military Services. The information regarding this once every three years collection just arrived in our office. Note that there is also new information regarding the Voluntary Catholic Schools Collection and the NCEA online Giving Promotion.

Please discard the previous Second Collections published last June and replace it with this updated list.

Also according to Archdiocesan policy, please remember the following:

1. Parishes should deposit all funds received for a second collection into the parish bank account and then remit a single check for the total amount to the Department of Financial Services.
2. Parishes should remit their second collection monies to the Department of Financial Services within two months of the collection.
3. Parishes should record all second collection donations in their parishioners' donor records.
4. When remitting monies please be sure that the name of the collection is clearly specified. (Parishes can remit more than one second collection on a check as long as the amount remitted for each collection is clearly noted.)
