*All families are required to create a FACTS account and participate in the FACTS Tuition Management Program.

*Families have a choice of paying their tuition by automatic payment from their checking or savings account or credit card on the the 1st, 10th, 15th or 20th of every month through FACTS.

Tuition Payment Plans:

Annual Payment Plan - tuition due in July 2019

Semester Payment Plan - 1st semester tuition due July 2019. 2nd semester tuition due January 2020

11 Month Payment Plan - tuition prorated over 11 months (July - May)

10 Month Payment Plan - tuition prorated over 10 months (Aug -May)

Bi-Monthly Plan starting in July - tuition prorated over 22 payments (July - May)

Bi-Monthly Plan starting in August - tuition prorated over 20 payments (Aug - May)

Sibling Discounts:

Families with 2 or more students enrolled will receive the following annual Tuition Discount(s). (Sibling Discounts are applied in grade order, highest to lowest, and are not allowed for Pre-K).

2 Students = \$350

3 Students = \$700

4 Students or more**=an additional \$350 discount will be added to the \$700 for each 4th child or more, except for PK .

** Families enrolled in the 14-15sy will be grandfathered and will not be charged tuition for 4 or more children.

This does not apply to Pre-Kindergarten tuition. Families will be charged fees.

Fees: All Fees are Non-Refundable

Returning Families are charged \$125 per child of the Annual Fees at Re-Registration in February. The remaining Annual Fees of \$265 plus all fees except for 8th grade graduation fee and reception fees are due by June 15th for all payment plans.

New Families are charged all fees at the time of registration

Tuition Assistance Opportunities

Hope for the Future

The Archdiocese of San Antonio Hope for the Future program provides need-based tuition assistance for **K-8th grade** Catholic and non-Catholic students who meet eligibility requirements. Tuition assistance is prioritized by financial need and based on available funding.

Families must apply online at www.hopeforfuture.org or <https://online.factsmgt.com/aid> and pay a \$35 non-refundable application fee. Please visit www.hopeforfuture.org for more information and deadlines.

St. Matthew School Tuition Assistance

St. Matthew provides need-based tuition assistance to enrolled **K-8th grade** students prioritized by financial needs and based on available funding. St. Matthew uses the same application as Hope for the Future for determining assistance through our own pool of funds, so applicants need only apply once through Hope for the Future to be considered for tuition assistance through St. Matthew School.

* For both programs, funding does not automatically carry forward each school year. An application must be submitted for each subsequent year of enrollment. A complete application must contain income verification. Only complete applications will be considered and only families with a \$0 balance at school will be awarded.
