FINANCIAL SECRETARY'S REPORT

Dues: I am happy to report that dues payments have been rolling in record numbers. I want to thank everyone for paying in such a timely fashion. For those of you who may have misplaced their notice, dues are \$110 for Regular Members, \$55 for Honorary Members and \$40 for Honorary Life Members. Checks can be mailed to the attention of the Financial Secretary at the Council address.

Second Notices: Second dues notices will be sent out in March. I am purposely sending them out at this time, so that members who have not yet paid will get a "double whammy" in the mailbox when the first quarter dues notices follow just a couple of weeks later. I hope that by timing the mailings correctly, EDW's delinquency rate will continue to decline even further than it has.

Charity: As I've processed the dues collection, I find myself amazed at the generosity of our members. A good number of our members contribute well above and beyond their dues obligation for the Penny a Knight a Day Fund (PKD), for charity and to support the building fund. Thank you to everyone who has gone above and beyond your basic dues responsibility. Every little bit helps.

Looming Costs to Keep the EDW Property Viable: In this month's Knight Life, you will find an article prepared by the President of the Columbus Club concerning the projected costs to fix a number of problems on the property and help keep EDW viable. The number is somewhat staggering and approaches \$600,000.00. I assure you that these expenses are well justified and are "must haves" in order to ensure the operation of our property for years to come...but this is money that we don't have! Over the coming months, the Council Officers and Columbus Club Board of Directors will begin to layout a plan to raise funds and address these very significant costs. Whatever that plan will be is yet to be seen, but I encourage you to patronize EDW whenever possible, participate in future fund raising activities and generously give to the building fund whenever possible. EDW is special. Let's work together to keep it as a landmark Council!

Death Notices: I have continued to observe that member deaths are still not being reported to me. Please make your family members aware that they should contact me to report a death and I will ensure a notice is published in the Washington Post. Additionally, members are asked to advise me of the deaths of their friends- even if the death is not reported timely- so that I can ensure that our membership records are up to date.

Modernization: I am beginning a "modernization project" to bring EDW's record keeping process into the 21st Century. Over the coming two months, I hope to complete the Council's transition to a commercial accounting software system (the same system already being used by the Columbus Club). In this process, I intend to conduct a membership audit to ensure that our member lists reconcile with the list maintained by Supreme. These initiatives should serve our members well for years to come.

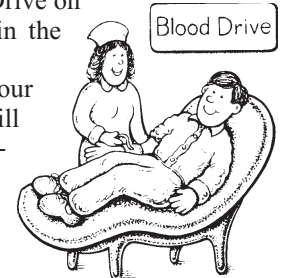

RIGHT TO LIFE NEWS

Brother Knights, here is an interesting article from Fr. Richard John Neuhaus, publisher of the *First Things* journal:

If It Can Be Done It Will Be Done. That is the motto of those who are eager to take us into Huxley's brave new world, and beyond. If it can be done it must be done, is the argument of such as Ray Kurzweil who writes of "the Singularity," the impending moment in which technology takes over from nature in the evolution of the human species. At this preliminary point we are still arguing about issues such as the creation and exploitation of embryonic stem cells, but Robert George of Princeton, a frequent contributor to these pages and member of the President's Council on Bioethics, says the post-humanists have bigger things in mind. Witness their coolness to the breakthrough that permits the production of embryonic-type stem cells that can do everything that embryonic stem cells do but do so without creating or destroying a human embryo. Not to mention their indifference to the fact that, while adult and umbilical-cord stem cells are being used in the treatment of many diseases, there is not even one embryonic stem cell therapy even in clinical trials. So what do the scientific post-humanists really want? They want, says George, to move beyond embryos to fetuses. With "fetal farming," they will be able to exploit and destroy unborn children at will. New Jersey already permits this, and is urging other states to follow its lead. Robert George writes: "So we find ourselves at a critical juncture. On the one hand, techniques for obtaining pluripotent stem cells without destroying embryos will, it appears, soon eliminate any plausible argument for killing pre-implantation embryos. This is great news. On the other hand, these developments have, if I am correct, smoked out the true objectives of at least some who have been leading the charge for embryonic stem cell research. Things cannot remain as they are. The battle over embryonic stem cell research will determine whether we as a people move in the direction of restoring our sanctity of life ethic, or go in precisely the opposite direction. Either we will protect embryonic human life more fully than we do now, or we will begin creating human beings precisely as 'organ factories.' Those of us on the pro-life side must take the measure of the problem quickly so that we can develop and begin implementing a strategy that takes the nation in the honorable direction." *First Things*, "While we're at it," December, 2005

UPDATE ON CAPITAL IMPROVEMENTS FOR THE COUNCIL HOME

Over the past couple of months, we have been updating you on the Capital Improvements that are required to be made to our Council Home. These improvements are not luxuries items but basic maintenance items required to be performed periodically to any home. We are no longer in a position to ignore them or apply band aid repairs. Failure to effect these repairs will simply be neglecting our home.

Tom Hazzard, our current VP and Chairmen of the Capital Improvement Committee, has been obtaining estimates from the various trades. Several of the trades have already submitted final bids. Tom's professional experience is in the design and construction of large scale custom homes which we feel makes him best qualified to oversee this project.

His committee has formulated a cost budget for the required improvements, currently estimated at \$195,000. We have included this budget for your review in this Knight Life.

Now, the question becomes- *How do we fund these improvements?*

1. As recently suggested by an active member, simply abandon the home.
2. Take out a loan to finance the improvements
3. Increase the dues to cover the cost
4. Do a special assessment to all the members
5. Do a combination of the above.

For financing advice we have tapped into Jim Nelson, a long standing member of the KOC. Jim is a Senior Vice President and Relationship Manager for Potomac Bank in VA. Jim works with both business and professional clients to help them implement business plans through cash management, loans for expansion and acquisition, lines of credit, etc. He has more than 20 years of banking experience in small business and consumer lending. Previously, he was with Sequoia Bank. Jim was very involved when we renovated the Banquet Hall back in 2000 and again it was his bank that did the financing. Jim and Potomac Bank have been good friends

Our current loan with Potomac Bank of Virginal is about \$75k, maturity date 12/10/2209, 5 year note (60 months-34 months remaining) @ 7.00%, original amount \$100,800.

Jim's recommendation is that we should submit for a new \$200K loan for the capital improvements and leave the cur-

rent loan in place with 34 months remaining. We then would have a new loan of \$200k @ 7.75%. The approximate monthly P&I payment would be about \$4,031 for a 5 year note or \$3,100 for a 7 year note. This would be a note/loan that we could draw down as needed as improvements are to be paid for and there would be no prepayment penalty. Our goal would be to obtain the financing now so that the improvements can be done, and then to quickly reduce the debt by implementing a special assessment and/or a dues increase, and/or have a building fund raiser in the summer.

Another thought for the payment of the improvements could be to allow someone to contribute a sizeable donation on behalf of a member so that his name or their family name could be associated with the Council Home name. For example "The John Smith Council Home"

As the board of directors, we are Individuals elected by the membership of the KOC to oversee the management of the corporation, and assume legal responsibility for corporate activities. The primary responsibility of the Board of Directors is to protect the members' assets. To this charge we are ready to present our findings to the membership so that a decision can be made. Does the Home get demolished, or do we abandon the Home and close it, or do we all agree to our fiduciary responsibility as members of the KOC and agree on the appropriate funding method.

We are targeting April or May of this year to begin the improvements. We will provide completed bids, cost and financing information. The membership commitment and approval of this project will be the final factor on moving forward.

So now, our membership is at a crossroads and decisions need to be made. We welcome your feedback and comments. All comments are appreciated and will be considered...
