2019 SCHOLARSHIP PROGRAM

Thank you for your inquiry about the scholarship program offered by the Catholic Union of Texas, The KJT and the KJT Memorial Foundation. The information below explains our scholarship program.

1. Applicants for a KJT scholarship or a KJT Memorial Foundation scholarship **must be KJT insured members for one year** prior to the application deadline of March first (1st) of the year before graduating from high school.

2. The Catholic Union of Texas, The KJT, offers \$20,000 in scholarships ranging from \$800 - \$1,500 each to the most qualified KJT members who will be enrolling in an institution of higher learning or vocational trade school. If any of the scholarship winners enroll in a Catholic institution, the scholarship award is doubled up to \$3,000.00.

3. The KJT Memorial Foundation, our charitable, educational and non-profit organization, will offer two scholarships of \$800.00 each. The scholarships will be awarded to applicants attending a vocational or technical school or enrolled in a technical course regardless of his/her ranking.

4. The scholarship winners are selected by a non KJT member panel with academic backgrounds to insure judgment is fair and impartial.

5. Scholarship awards are payable in two (2) installments. One half of the scholarship award will be payable upon enrollment and the remaining half of the award will be paid upon successful completion of the first semester and enrollment for the second semester.

6. Scholarship winners will be eligible for only one scholarship. Scholarship winners must enroll in an institution of higher learning or vocational trade school within one year from the date notified of the scholarship award, and if curriculum commitments are not completed within one year thereafter, the Board of Directors may award all the remaining portion of such scholarship award to the next alternate scholarship winner.

7. Amount awarded is weighted according to the applicant's performance in the following four (4) categories during the previous four (4) years only:

- A. Scholastic achievement
- B. Extracurricular and Community Activity
- C. Church Participation
- D. State and Local KJT Involvement and Contributions

When listing your involvement in the KJT on the local, district and state level, please be as specific as possible.

8. Applications must be fully completed and accompanied by a copy of the high school transcript through the fall semester of the school year of graduation, 2 letters of recommendation and applicant's photo. Mailed applications must be postmarked no later than March 1, 2019 to be considered.

An applicant must be a K.J.T. Insured member for one (1) year prior to the application deadline. Applicant must be a 2019 high school graduate and must meet all qualifications for entry into and be accepted by the institution named below.
